Ocean exhibits this all through his sound structure, a front assembly which allows him to move with precise gait and movement that enables him to easily cover the ground with powerful drive and reach, a beautiful deep medium golden colored coat with correct texture, a top line that remains correct in a stack or in motion. Just as noteworthy, Ocean has full dentition with a correct bite, and black pigment (which includes never having a "snow nose" in the winter) even down to his toe nails. In addition and even more important as any other aspect of the breed, Ocean possesses the "golden retriever" temperament, with all of its grace, strength, and joy, which makes him a prime example of his pedigree and the breed.

Career highlights: Having just turned 2 years of age in April of this year, Ocean has had an outstanding show career, to date. Beginner's luck was with him when his first showing brought him the Reserve Winner's dog ribbon. Followed by additional major reserves and a few other ribbons, Ocean took his first point, and then headed home to have fun and mature. Upon his return to the ring, Ocean struck gold with his first appearance in the Open class and took his first major. With 4 majors total to his credit, we are pleased to have earned the title champion within limited showings. The ride has been oh so sweet!

Away from the show ring, Ocean is known to favor "lounging" on his sofa when not playing with the other Forever Goldens gang members, hanging out with me at the hotel and greeting guests or running in the acreage surrounding the house. STUD SERVICE AGREEMENT

Under the terms of this agreement, the undersigned parties agree to the following conditions in regard to the breeding of the Golden Retrievers identified below:

The owner(s) of the above identified stud dog,
Candy Nee, agree as follows:

THAT a stud service will be given by this stud dog to this bitch during her next season;

THAT this service will be given as soon as she will stand, and subsequently every 48 hours for as long as she will stand, unless otherwise instructed by her owner(s);

THAT if less than three puppies are named on the AKC Application for Litter Registration, the \$400 non-refundable deposit will be the payment to stud dog owner in lieu of the full stud fee, and this contract will be considered fulfilled. If there are no puppies, a repeat service will be given to this bitch during her next season, provided the stud dog does not change possession;

THAT in the event of a repeat service, another bitch may be substituted provided she meets the requirements of this agreement and with approval of the stud dog owner; a \$50.00 service charge will be paid by the owner of the bitch at the time of the repeat service;

THAT every effort will be made to provide a safe and comfortable environment during the bitch's visit and those specific instructions will be carefully followed.

The owner(s) of the above-identified bitch,
_____ agree(s) as follows:

THAT the fee for this service is \$ 1000.00. A non-refundable deposit of \$400.00 will be paid at the time of the breeding. The balance of \$600.00 will be paid no later than two weeks after the date of the whelping. Please note these fee requirements and deadlines.

THAT the owner(s) of the bitch will be responsible for transportation of said bitch to and from the stud owner's residence and agree(s) to deliver her in sufficient time to adjust to her new surroundings prior to service, *and that she arrive clean and free of internal and external parasites.*

THAT any expenses related to the bitch's care in travel to and from an AIRPORT (GAS REINBURSTMENT)

or breeding, boarding of Ocean, do to time slots of breeding at \$15.00 a day to Veterinary clinic (veterinary expenses, smears, artificial inseminations, health certificates, etc.) will be promptly prepaid to the clinic in which used before the inseminations are final

THAT board will be paid at the rate of \$15.00 per day after the first 10 days of the bitch's visit.

THAT in order to achieve the highest possible rate of conception and litter size, the stud dog owner may deny service to this bitch if at the time she comes in season, the demand for his services are greater than he is capable of providing;

THAT prior to the breeding, **the stud dog owner will be provided with the bitch's AKC (or CKC) registration, OFA clearances, a CERF clearance or eye clearance conducted by a member of ACVO within the past 12 months, a negative fecal and brucellosis certificate, and a full vaginal culture report** within 30 days prior to the breeding, and a current immunization record for DHLPP, Parvovirus, and Rabies.

THAT the owner(s) of the bitch agree not to sell any puppies resulting from this breeding to dog brokers, litter lot buyers or agents representing foreign purchasers or individual foreign purchaser outside the United States or Canada without the stud dog owners consent, and that printed advertising of the litter is not allowed, EXCEPT in Golden Retriever Club publications;

THAT the stud dog owner will be provided with the names and addresses of all puppy buyers and all puppies' AKC registered names resulting from this breeding.
